BOOTH RENTAL AGREEMENT

The SDAPI Culinary Fusion Festival Organizing Committee hereinafter referred to as SDAPI OC permits the vendor listed at the bottom of this agreement, hereinafter referred to as VENDOR to use the Rental Booth facilities in accordance with the following agreement:

BEFORE THE FESTIVAL

1. The VENDOR agrees to observe and comply with all existing policies which in any manner affect or relate to the use of the Rental Booth.
2. The SDAPI OC reserves the right to evict anyone violating any of the rules outlined herein, or violating any other rules and regulations.
3. The VENDOR may not sub-let any portion of the rental booth space, without the prior written consent of SDAPIOC.
4. Refunds for booth rental before September 12, 2016 will be at 50% of booth cost. No refunds will be given after September 12, 2016 unless the event is canceled. Weather conditions will not be grounds for refunds, full or partial, unless weather causes cancellation of the event.
5. One week before the festival you will be required to read and understand directives for the day's set up and break down procedures.

DURING THE FESTIVAL

6. Booths are rented for the duration of the SDAPI festival only. **Rental shall begin at 7:00 AM and end at 3:00 PM** on September 17, 2016.
7. SDAPI OC agrees to provide (1) Canopy, (1) Table & (2) Chairs, during the event to vendors that specifically indicate this need in the application and submit payment for equipment rental. Unless noted, all vendors are responsible for bringing their own material.
8. The Booth must be accepted as assigned. VENDORS are **not permitted to remove and/or relocate** the rental booth from the assigned spot without prior approval of SDAPI OC. It is SDAPI OC's right to relocate the rental booth should it deem necessary.
9. The VENDOR **may not sell or provide water, soda, or any beverages** without consent of SDAPI OC. SDAPI OC will handle distribution of beverages.
10. SDAPI OC reserves the right to inspect the information being distributed or the products being offered for sale by the VENDOR, and restricts the distribution of any item it considers as in violation of existing federal, state, and local laws and ordinances and shall retain the right to disallow what it deems inappropriate for the event. SDAPI OC reserves the right to deny sale or display of objectionable or offensive materials.
11. By participating, you understand that at this event, you may be photographed or video recorded and you agree to allow photo, video, or film likeness to be used for any legitimate purpose, including marketing, by the event holders, producers, or organizers.

OVERALL RIGHTS & RESPONSIBILITIES

12. This Agreement shall be subject to the applicable laws of California. Any disputes arising from this Agreement shall be brought before the county courts of San Diego, California.
13. The VENDOR indemnifies and agrees to hold the SDAPI OC, the City of San Diego and any associated agencies affiliated with the festival event and their members, officers and directors, and employees, harmless against any and all liability (including court costs and attorney's fees) whatsoever arising from any claim made against SDAPI OC or loss incurred by the VENDOR as a result of or in any way arising from, relating to, or connected with the obligations identified within this VENDOR's Agreement including loss or liability caused by active negligence, except loss or liability caused by sole negligence or willful conduct. The VENDOR will act as the sole, distributor, supplier and/or manufacturer of products sold in SDAPI, hence will be solely held liable for claims associated with products sold to customers at SDAPI only.
14. You understand that at this event or related activities, you may be photographed or video recorded and you agree to allow photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, or organizers.
15. This agreement for Booth Space at the 2013 SDAPI Festival indicates the VENDOR's willingness to abide by all accompanying terms and conditions and general regulations listed on this document as well as such additional rules and regulations as SDAPI OC deems necessary for the success of the SDAPI Festival, provided these latter do not materially alter the Participant's contractual rights.
16. Applications received after **September 5, 2016 will incur a late processing fee of \$25 at the discretion of the SDAPI OC.**
